Government employees who apply pesticides must obtain a commercial applicator license, but may be fee exempt. The SDDA maintains a searchable database of commercial applicators.

Commercial Applicator License's and category certification is valid for 2 years. License and category certification renewal is required biannually. A fee of \$25 is required at the time of renewal.

A commercial applicator license applies to any applicator (whether or not the applicator is a private applicator with respect to some uses) who uses or supervises the use of any pesticide which classified for restricted
